In general, you will have to apply for and be granted a permit before travelling to Sweden. You can apply for a residence and work permit on www.migrationsverket.se or submit your application at a Swedish embassy or consulate general.

If you provide all the information in your form and include all the required documents, you will receive your decision sooner than if we have to ask you for supplementary information.
